

Privacy Policy

This Privacy Policy determines how Chistaya Planeta collects, uses, stores and discloses information received from users on the website <http://www.vtormadv.ru/> (the "Site"). This privacy policy applies to the Site, to all subdomains of the Site and to all products and services offered by Chistaya Planeta.

This page contains information about information what we or third parties can receive when you use our Site. We hope that this information will help you to make informed decisions about the information, which you give us about yourself.

This Privacy Policy applies to this Site directly and to the obtained information with its help. It does not apply to any other sites and does not apply to third party websites that may contain a mention of our Site and from which you can find our Site.

Received information

When you visit the Site, we determine the IP address, the domain name from which you came to us (for example, "yandex.ru") and the country of registration of this IP, and fix all the visitor transitions from one page of the Site to another.

The information which we receive on the Site can be used to facilitate the use of the Site. The site collects only general information that your browser provides voluntarily when you visit the Site.

The site uses the standard technology "cookies" ("cookies") to customize the display styles of the Site for the monitor screen settings. "Cookies" is data from a website that stores on your computer's hard drive. The "cookies" contain information that may be necessary for setting up the Site - to save your viewing options and collect statistical information on the Site, what pages you visited, what was downloaded, the domain name and the country of the visitor, the addresses of third-party websites from which the transition to the site went on.

We can collect personal identification information from users when a user makes an order on the Site. We can ask if it is necessary to specify a name, email address, telephone number. Users can visit our Site anonymously. We collect personal identification information of users only if they provide us with such information voluntarily. Users can always refuse to provide personal identification information, except when this may interfere with the use of certain functions of the Site.

How we use the collected information

The company Chistaya Planeta can collect and use personal information of users for the following purposes:

- To improve customer service. The information helps us to respond more effectively to customer needs;
- To improve our site. We can use the feedback to improve our products and services;
- To send users information which they agreed to receive on topics that we think will be interesting to them;
- To send periodic e-mail messages, which may include company news, updates, information about products and services, etc. If the user would like to refuse receiving follow-up letters, we include a detailed description of the instructions how to unsubscribe at the bottom of each email or the user can contact us through our Site.

Personal Information of the User

By entering personal data in the form of feedback on the Site, clicking on the "Send" button, the User decides to provide his / her personal data and agrees to process his will and interest, and this consent of the User is specific and conscious.

Personal data received from the User who is the subject of personal data is used by the site administration solely for the purpose of concluding agreements with the User or for the performance of an concluded contract. The User's personal information, its confidentiality is preserved and cannot be provided to third parties without the consent of the User, except in the cases and expressly provided by the current legislation of the Russian Federation.

The Site Administration does not verify the authenticity of the personal information provided by Users and does not verify their legal capacity. At the same time, the Site Administration proceeds from the fact that the information transmitted to them from users is reliable.

The user is responsible for the provision of personal data of a third party.

Personal data entered by the User in completing the feedback form can be used by the Site Administration to prepare and submit an offer, complete a transaction, perform a service or improve the quality of service.

The User agrees that the Administration of the Site has the right to use the User's personal data for the implementation of electronic news or advertising distribution, including by means of email letters and SMS messages.

Processing of personal data of Users

Acceptance of the terms of this Policy with regard to the provisions on the processing of personal data is carried out by the possibility of passing through a special link for acquaintance with the Privacy Policy, which can be read by User, and is the expressed informed consent of the User to the processing of personal data.

The User agrees that the Administration of the Site has the right to store and process any information related to the User's personal data in accordance with Federal Law No. 152-FZ of July 27, 2006 "On Personal Data", including collection, systematization, accumulation, storage, clarification, use, distribution (including transfer), depersonalization, blocking, destruction of personal data provided by the User when filling out the feedback form on the Site.

Consent to the processing of personal data may be withdrawn by the User at any time. When the User withdraws consent to the processing of personal data, the Site Administration deletes the User's personal data and is not entitled to use them in the future.

How we protect your information

The Administration of the Site ensures the confidentiality and safety the personal data. We take appropriate security measures to collect, store and process any collected data to protect them from unauthorized access, alteration, disclosure or destruction of your personal information.

Access to the personal information

We do not sell, exchange or rent out personal information of users. We can give aggregated demographic data which is not related to personal information, to our partners, or advertisers for the purposes described above with. We can use third-party service providers to help us manage the Site or manage activities on our behalf, for example, mailing or statistical and other research. We may share this information with these third parties for limited purposes with the resolution from the User.

Changes to Privacy Policy

The company "Clean Planet" has the right to update this privacy policy at any time. In this case, we will publish a notice on the main page of our Site and let you know by e-mail. We recommend to check this page in order to be aware of any changes and know how we protect the personal information. By using the Site, you agree to be responsible for periodically reviewing the Privacy Policy and the changes.
